This form must be completed in full by a participating NC Fuel Oil Dealer. Submission of the application form constitutes a representation on the part of the participating NC Fuel Oil Dealer that the work shown on the form has actually been completed. The NC Fuel Oil Dealer shall confirm with NCPCM staff that funds are available before starting the installation process.

This form and receipts showing purchase of each tank must be submitted to the NC Petroleum & Convenience Marketers for the customer to be eligible for consideration of any rebate(s). Failure to furnish all necessary documentation will result in the customer being declared ineligible for consideration of any rebate(s). The NC Petroleum & Convenience Marketers assume no liability for a customer being declared ineligible for consideration of any rebate(s). Rebate checks payable to NC Fuel Oil Dealers only.

The "Heating Oil Tank Replacement Fund" (ending 4-30-2017) program is for low income families with old tanks. Fund will not be used to install new USTs. Fund will only be used to replace questionable ASTs or USTs with new ASTs. Must provide NORA Tank inspection form fill in by NC Fuel Oil Dealer. The NORA Forms are "Routine Fuel Oil Storage Tank Evaluation – In ground tanks" & Routine Fuel Oil Storage Tank Evaluation–Above Ground Tanks. After inspection by marketer using one of the attached forms for (USTS/ASTS), NC NORA would provide \$500.00 rebate for tank replacement upon submittal of proper form(s) and invoice for new tank.
